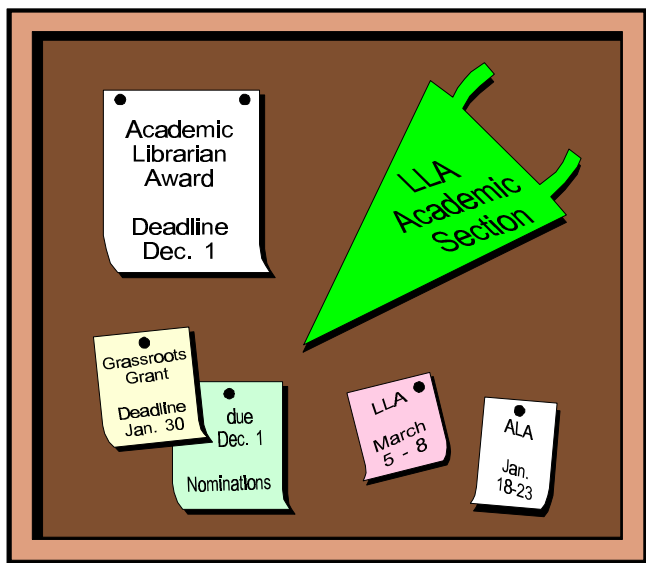

#### US Civil War Center

From portraits and personalities to popular culture, *Civil War Book Review*, a quarterly journal published by the United States Civil War Center at LSU and BookPage in Nashville, Tennessee, reveals the latest in Civil War scholarship. The Fall 2001 issue includes Wiley Sword's take on politicians and Confederate decline



in two new works by William C. Davis, *An Honorable Defeat* and *The Union that Shaped the Confederacy*. Other key features include an interview with scholar Harold Holzer on the power of Lincoln's image; Carolyn Yoder's review of *Red Legs*, a young-adult title focused on the world of reenacting; and Lawrence Kreiser's examination of the war's effect on popular culture as reflected in eight diverse works.

*Civil War Book Review* is the journal of record for new or newly reprinted books about the Antebellum, Civil War, and Reconstruction eras. *Civil War Book Review* is a project of the United States Civil War Center and LSU Libraries Special Collections. This exhibition will feature more than 50 children's books on the American Civil War published from 1862 to 2001. Varied in subject matter and style, these books project a complex mosaic of American identity, cast in the singular image of the Civil War.

**Leah W. Jewett**, director of the Center, has selected the books and provided informative commentary on the authors and genres represented. A free lecture by scholar James Marten, professor of history at Marquette University and an expert on Civil War children's literature, is planned for November 15 at 7:00 pm at Hill Memorial Library.

The exhibit will be displayed in the second-floor gallery of Hill Memorial Library, November 12, 2001 - March 3, 2002. Prints from artist Edwin Forbes's post-war portfolio *Life Studies of the Great Army* will be displayed simultaneously in the first floor gallery.

### T. Harry Williams Center for Oral History

In the Spring of 2001, the Center published its annual newsletter, *Oral History in Louisiana*. The Center also continues to sell its teacher's manual/video, *Talking Gumbo/"You've Got to Hear This Story."*

### MCNEESE STATE UNIVERSITY Library

**Nancy Khoury**, library director, is serving as 2001/2002 President of the Louisiana Academic Libraries Information Network Consortium (LALINC).

**Kathie Bordelon**, archivist and special collections librarian, has completed work on *McNeese State University*, a book featuring nearly 240 photographs which document the history of the institution.

**Ryan Patrick Semmes** is new assistant archivist at Frazar Memorial Library. Mr. Semmes comes to McNeese from the University of South Carolina, where he recently earned an M.L.I.S. degree.

### NUNEZ COMMUNITY COLLEGE Library

**Karen Leeseburg**, assistant director for public services, has received a grant from Entergy entitled "High School to Higher Education @ Your Library." Through this grant, juniors and seniors from area high schools will have the opportunity to do research in the college library and tour the campus. The goal is to expose high school students to college life so that they may consider continuing their education at Nunez.

**Barbara Vaughn**, archives, has received a preservation grant from the National Endowment for the Humanities. The grant will be used to assess the preservation needs in the archives department.

### TULANE UNIVERSITY Libraries

Specifically, the project proposes to extend Tulane's leadership in the area of Women's Studies through a revised edition of the *New Orleans Guide to Collections on Women*, through a study on gender and library use, and through the development of an electronic portal for research on women.

**Lance Query**, dean of libraries, **Andy Corrigan**, assistant dean for research and information services, and **Jean-Paul Orgeron**, head of the Center for Library User Education, received a RosaMary Foundation grant to build classrooms in Howard-Tilton Memorial Library. Completed this summer, the classrooms feature state-of-the-art technology and are dedicated to furthering information literacy on Tulane's uptown campus.

**Leon Miller**, manuscripts librarian, became president of the Academy of Certified Archivists at the organization's August meeting in Washington, DC. At the August meeting of the Society of American Archivists (SAA), Miller presented the paper "The SAA Mentoring Program: Ten Years Later." Miller founded the SAA Mentoring Program in 1991. It currently serves over two hundred archivists around the world.

## Outstanding Academic Librarian Award

The Outstanding Academic Librarian Award Committee seeks nominations for the Outstanding Academic Librarian. Sponsored by the Academic Section, the award publicly recognizes "an individual who has made an especially significant contribution to further the development of academic libraries/librarians/librarianship within Louisiana."

Nominees must be an academic librarian currently active in his or her profession in Louisiana. On rare occasions a non-librarian who has made exceptional contributions to academic librarianship in Louisiana may be considered. Contributions must be of value to libraries or librarians as a whole, not to individual persons or institutions. Contributions, such as creating a "model library" on a particular campus, must be profound enough to be of wide interest and easily accessible for other libraries to benefit from their creation. Nominations must be made by a current member of LLA.

Nominees should be characterized by one or more of the following:

1. Actively participates in professional activities which enrich the ability of academic librarians to enhance library usage.
2. Conducts research and shares this research with other Louisiana academic librarians (either through publication or through public presentations) which enriches the ability of library users to more fully utilize current information resources and technologies.
3. Serves as a model for other librarians or potential librarians who can help further the impact of Louisiana academic libraries on the education and/or livelihood of Louisiana's students and residents.

### **Nomination deadline is December 1, 2001**

Nominations, in the form of a letter, must be submitted to Ginger Bryan, Bossier Parish Community College Library, 2719 Airline Drive, Bossier City, LA 71111.

Letters of nomination should include:

1. The full name, work address, telephone number, and e-mail address (if available) of the nominee.
2. An outline of the nominee's contributions to academic librarianship.
3. List of all special accomplishments credited to the nominee.

Nominations and accompanying documentation for candidates not chosen for the award in a given year will be kept in the committee files for two additional years; the person who made the original nomination must submit a new letter to renew and update the candidate's nomination for the award.

## Thorpe Grassroots Grant Award

This grant/award is not new to LLA, it is new to the Academic Section. At their business meeting last year, the Academic Section was asked to consider co-sponsoring this grant with Thorpe Associates. It was previously co-sponsored by NMRT.

The purpose of this award is to encourage library science students to attend state library conferences and to recognize outstanding graduates or undergraduate library science students.

The prerequisites are:

1. Must be a full-time or part-time graduate or undergraduate student majoring or minoring in library science and attending a Louisiana college or university.
2. Can be a full-time or part-time student enrolled in a library tech program (two year) at an accredited two-year or four-year college.
3. Individual must be a student at the time of application, but not necessarily at the time of conference.
4. Must be a current member of LLA.

The nominees will be judged from the information given on the application form and from the accompanying letters of recommendation. Selection will be based on the nominee's professional promise and demonstrated leadership ability.

The winner of this award will receive an engraved plaque and a \$250.00 check from Thorpe Associates for expenses incurred in attending the LLA conference and a ribbon to be worn at the conference.
