#### Academic Section Business Meeting, LLA Annual Conference

Capital Hilton Hotel, Baton Rouge, Louisiana Thursday, March 11, 2010

The meeting began at 4:00 p.m.

#### **Introductions**

New Officers: Chair Donald Smith (UL Monroe), Vice-Chair/Chair Elect Nicole Morello (BRCC), and Secretary Karen Niemla (UL Monroe)

Outstanding Academic Librarian 2010: Lori Smith (Southeastern)

Grassroots Award: Kristi Kohl (LSU SLIS)

#### Chair's Report and New Business

Chair Rob Bremer welcomed all and thanked by name the Section's officers and committee chairs for their fine work this year.

Grassroots Award. Guidelines state that the recipient be named by December 1. SLIS has requested the announcement date be delayed to January 31.

Request for approval to change the recipient announcement date from December 1 to January 31; Vote taken by show of hands; Passed.

Students working on a graduate or undergraduate library and information science degree are eligible to receive the award, but with little evidence that an undergraduate program is being offered at institutions, the award is given to a graduate student.

Request for approval to grant the award to a graduate student unless there is a qualified undergraduate candidate; Vote taken by show of hands; Passed.

Library Legislative Day. April 21, 2010, is Library Legislative Day. The Louisiana Library Association has asked various sections for donations of \$400-\$500 to support this charge. The monies would be used for promotional materials and gifts for legislators.

Discussion followed about using a portion of the section's discretionary funds to support the association's push, the appropriateness of giving gifts to legislators, whether the specific concerns of the Academic section would be addressed, and a possible family day for LLA members.

Request for permission to donate \$400-\$500 of the Academic section's discretionary funds to the Louisiana Library Association in support of Library Legislative Day; Vote taken by show of hands; Passed.

Debra Rollins (LSUA) and Sybil Boudreaux (UNO) were appointed to represent the Academic section on the Library Legislative Day task force by Bremer.

Conference programs. The Academic section sponsored at total of 14 programs at conference this year, including 3 pre-conference programs.

Old Business: None.

#### Other Business

The University of Louisiana System's new financial exigency policy was mentioned.

Sybil Boudreaux (UNO) discussed the creation of a document by the UNO Faculty Senate that is to be used to measure programs and set up standards on what should be cut, and mentioned a possible higher education rally in Baton Rouge sometime in May.

**Brad Wiles** gave a presentation at the annual meeting of the Popular Culture Association/American Culture Association in St. Louis, MO, on April 1, 2010. The presentation was entitled "Power, Politics, and Perversion: The Archive in James Ellroys' L.A. Quartet and Underworld Trilogy." Wiles also had an article published in *Collections: A Journal for Museum and Archives Professionals.* The article is called "Selling the Collections: Internal Marketing in Archives and Records Management."

## Louisiana Tech University

Tom Aswell, the author of *Louisiana Rocks! The True Genesis of Rock and Roll*, gave a talk about his research for the book and signed copies Friday, April 16, 2010, in Prescott Memorial Library. Aswell, a 1970 Tech journalism graduate, said he hopes readers learn about the legacy of music in this state and develop an appreciation for the impact that Louisiana had on popular music.

Aswell said his reason for writing the book was to bring attention to what he views as the state's most important contribution to culture: music. Tom Aswell considers the Louisianan influences of swamp pop, Cajun, zydeco, R & B, rockabilly, country, and blues music to detail the ways in which these musical forms mixed and gave birth to rock and roll as we know it today. On an earlier visit, Aswell donated 2 copies of his book to Prescott Library.

Afterward, the library hosted a small reception. **Debora Rathburn** from Government Documents replicated an exact copy of the book's front cover onto a sheet cake, a delicious accompaniment to a wonderful presentation.

Prescott Memorial Library received a \$5,000 grant from the Lagniappe Ladies, Louisiana Tech's ladies-only giving society. The grant is funding for their liberal arts book collection. Forty-four grant applications were made, and the library was one of seven to receive funding. **Mike DiCarlo**, dean of library services, and **Lynell Buckley**, head of reference, were the principal investigators.

#### Loyola University

**Trish Nugent**, special collections librarian/archivist, was recently awarded the 2010 American Heritage Preservation Program Grant from the Institute of Museum and Library Services. The grant will fund the purchase of environmental monitoring equipment for Special Collections and Archives storage areas.

In conjunction with the opening of the Walker Percy Center for Writing and Publishing at Loyola University New Orleans, the Monroe Library's Special Collections and Archives is currently displaying selections from its collection of material created by and related to southern author Walker Percy. The exhibit, *Walker Percy: Books +Papers*, is on display through June 1, 2010, and is free and open to the public.

## Library news from around the state

#### Tulane University

On April 26, 2010, the Library welcomed a new director of public services, **Pat Vince**. She returned to her native Louisiana from a position as the library director for digital initiatives, records management and archives at the Claremont Colleges in Claremont, CA. Pat's involvement in the LOUISiana Digital Library was crucial in establishing the breadth of projects and depth of commitment to statewide digital education initiatives. Her undergraduate and graduate degrees were obtained from LSU. She also has a distinguished record of publications, presentations, and grants.

Howard-Tilton Memorial Library recently received the Stan Levenson Jazz Collection. A former New Orleans native turned Dallas businessman, Mr. Levenson's lifelong passion for jazz and collecting has resulted in an expansive, well-balanced collection of books, sound recordings, and video recordings in a variety of formats. Representing jazz interests in North America, Europe, and Japan, the Stan Levenson Jazz Collection contains materials running the gamut of jazz styles from early to modern jazz. The sheer size (over 700 LPs, 1,000 CDs, 1,000 video recordings, and more than 900 books) combined with its comprehensive nature places the Stan Levenson Jazz Collection among the best academic jazz research collections in the southern United States. The Library is pleased to have this collection and proud to make it available to students, scholars, and jazz aficionados alike.

# University of Louisiana at Lafayette

The current exhibit in the Great Hall of the Edith Garland Dupré Library features lap desks from the eighteenth and nineteenth centuries, selections from a large collection donated to the Library by George Newton, a UL Lafavette alumnus.

Long before the invention of laptop computers, PDAs and the like, our ancestors used their own portable writing boxes to compose and store their correspondence and other important papers.

Besides a writing surface, lap desks usually featured compartments for pens, ink, and sand or blotting paper, and storage for stationery and documents. Made of hardwoods like mahogany or walnut, with brass corners and bands for added strength, these sturdy boxes could withstand the rigors of travel over bad roads.

Later lap desks were often elaborately carved, or inlaid with beautiful woods, ivory, mother of pearl or silver in ornate patterns. Many included "secret" drawers hidden beneath the ink and pen compartments. These later desks were smaller and lighter than their predecessors.

Louisiana Room librarian **Jean Kiesel** created this exhibit, which includes twenty lap desks with a description of each item.
